WHEREAS, following meet-and-confer process, the parties stipulated to the Preliminary Conference Order entered by the Court on May 19, 2008;

WHEREAS, since then, the parties have engaged diligently in the meet-and-confer process to address each other's discovery requests;

WHEREAS, the parties have made a good faith effort to gather and review documents and electronically stored data responsive to each other's discovery requests with each party having deployed large teams of attorneys to gather and review such documents;

WHEREAS, there is an enormous volume of documents and electronically stored data (with each party experiencing several hundred thousand "hits" in response to each other's stipulated electronic search terms) that the parties have gathered to review in response to each other's discovery requests;

WHEREAS, the Preliminary Conference Order provided only until July 2008 to complete document productions; and

WHEREAS, the parties believe that it is necessary to extend the discovery deadlines set forth in the Preliminary Conference Order by approximately 120 days in order for them to

complete discovery in light of the sheer volume of documents and electronically stored data identified for review;






